

Encourage collaboration that improves sustainability, leadership wellbeing and outcomes for pupils






UNDERSTANDING

BENEFITS OF MEMBERSHIP

Category	Who it's for	What it includes
Full Membership	Registered non-association independent schools	Full access to NAISA support and services, including compliance, schools inspection and registration guidance; professional networks and forums; national representation; resources and briefings; events and learning opportunities; and use of the NAISA member logo
Affiliate Membership	Newly registered schools, prospective schools, or schools not yet eligible for Full Membership	Introductory access to guidance, updates, selected events and early-stage support
Associate Membership	Individuals or organisations connected to non-association independent schools (e.g. proprietors, governors, trustees, advisors)	Access to selected networks, briefings, guidance and events; opportunities to engage with the NAISA community
Supporter / Partner (optional)	Organisations aligned with NAISA's aims	Opportunities to engage with the NAISA community, share expertise and collaborate in ways that support member schools

ELIGIBILITY CRITERIA





FULL MEMBERSHIP

(for schools - annual fees, banded by pupil numbers)

Full Membership is open to schools that:

- Are registered as independent schools with the Department for Education
- Are not members of any of the associations that make up the Independent Schools Council (ISC)
- Are committed to meeting the Independent School Standards and to engaging constructively with support and improvement
- Share the aims and values of NAISA

Number of Pupils	Annual Fee
Up to 25 pupils	£650
26–50 pupils	£850
51–100 pupils	£1,400
101–150 pupils	£1,950
151+ pupils	£2,400

Schools at different stages of development, including those facing regulatory challenge, are encouraged to engage with NAISA.

Membership is intended to support schools, not to exclude them.



ASSOCIATE MEMBERSHIP

(for individuals/organisations)

Associate Membership is open to:

- Proprietors, governors and trustees connected to non-association independent schools
- Advisors or consultants who can demonstrate a clear understanding of the non-association independent school context and experience of successfully supporting schools within the sector

AFFILIATE MEMBERSHIP

(Introductory / developmental access)

Affiliate Membership is open to:

- Newly registered schools
- Prospective schools preparing for registration
- Schools not yet eligible for Full Membership but seeking early-stage guidance and connection


